Covers net loss and profits

E.g., costs \$10,000 to put on Messiah (must show this). Profits of \$5,000 in past years, will recover this, minus any amount received from presale ticket sales. Then would recover \$15,000 (assuming no presale tickets) in case of cancelation.

Messiah coverage is \$500

Fundraiser is an additional \$250. But, we don't know what out lost profits would be. Our loss would likely be \$2,500-\$3000.

Poinsettias have been ordered. \$175. Whatever Deb doesn't sell, Octavos will pick up. Next year, Octavos will purchase and resell. Extend invitation to orchestra to purchase.

**Motion** to buy Messiah coverage for \$500. Motion did not carry. 3 for, 2 against, 1 abstention Lighthouse post concert dinner, 65 person minimum. Not doing.

Should we extend an invitation to orchestra?

**Chamber:** Diane went to a breakfast. Request from Albany Empire about singing National Anthem. Must guarantee 65 tickets sold. Not going to do.
