Elections – Diane wants to plan for May 16, 2022. Candidates need to be posted by 5/2. We need to ask for candidates. Diane will send out an email asking for candidates and explaining that the Board needs help.

Positions open: Diane reported that Secretary (Katie) and Dave Roberts have both agreed to continue if needed. Meg Eckhardt's position is also up for election. She does not wish to continue.

There was a general discussion regarding whether action needed to be taken on any other positions. It was determined that the three mentioned above are the only positions up for election this year. Katie mentioned that Wendy was last appointed Treasurer at a meeting held 2/1/2021. Diane says our bylaws indicated that Treasurer is appointed biannually.

Diane says we need to have a short business meeting April 18, after rehearsal to talk about the need for Board members and help needed.

Diane says we need to look for venues for next year. Diane is looking for ideas. There was a general discussion about possible locations.

Diane will proceed with preparation for the concert and will let Board members know when she hears news about the orchestra availability.
