Hi All,

Not earth shattering but I sent Curtis his contract; he responded and I need to get an OK or not on the following:

1. Curtis' hourly rate for Beethoven and small concerts - He did not change it in his proposal from 82.50 when he sent it. He calls it 87.50 based on an hourly fee off the agreed upon \$7,000.
2. Curtis says that due the the caliber of folks involved he has not had to rehearse soloists at his house since St. John Passion but should he need to do so he would like his hourly fee of 87.50/hr for this.
3. If media or donor meetings require him to take time off work, he would like to be paid \$65/hr.

Item 1 flows from the agreed upon annual fee and likely not changing it was an oversight by him.

Items 2 and 3 are new. As for as I know there in only one publicity thing that is on work time and it does not appear that there will be much on the soloist end.

So I MOVE that we adopt the above provisions. Assuming someone seconds, I will need a vote. Unless the Legislature did something last month (will check) our vote has got to be unanimous by those who can vote or I will have to call a meeting and have a quorum probably before or after we are done on Monday.
